## TERMS AND CONDITIONS OF ENROLMENT

## **Enrolment Procedure**

- Send a completed application form to Greenwich English College or enrol online at http://www.greenwichcollege.com.au
- Greenwich English College will send you a Conditional Letter of Offer. Please take a moment to read through the Letter of Offer document (which includes the Letter of Offer, Tax Invoice, and Course Acceptance Agreement). Once you have confirmed that all of the details are correct, and agree to the Greenwich English College Terms and Conditions of Enrolment (as per the Application Form, Website and contained within the document), please sign and return the Student Course Acceptance Agreement along with payment
- Arrange payment of fees 1 month after the issue date of your Offer or at least 14 days prior to the commencement date of the course (whichever occurs first). Greenwich English College recommends early payment as places in some courses are limited and subject to availability at time of payment. For some applicants, payment may be required earlier. Please note that your place in the course will not be confirmed until receipt of full payment and confirmation by Greenwich English College
- For all enrollments into individual courses with total study durations of 24 weeks or less, please remit full payment of fees as specified on the Student Tax Invoice. For all enrollments into individual courses with total study durations of 25 weeks or more, please refer to the payment due dates (all fees must be paid by the date specified). Under the Tuition Protection Service (TPS) if a student has multiple courses (packaged courses), they would each be considered as separate courses (for courses with study durations of 24 weeks or less). Payment due dates for study periods in individual courses of 25 weeks or more are aligned to student study
- . Upon payment of fees, Greenwich English College will issue you the necessary documents for you to study at Greenwich English College
- All applicants who want to travel, work, and/or study in Australia must obtain a valid visa

## **Terms and Conditions of Enrolment**

- All accommodation and airport transfer requests must be made on this application form

Greenwich English College requires full payment and final arrival details a minimum of 14 days prior to your arrival date otherwise cannot guarantee your accommodation and/or airport transfer request

- You are required to give a minimum of 14 days notice to Greenwich English College before moving out of and/or changing your arranged accommodation. Additional placement fees may apply

#### **CANCELLATION AND REFUND POLICY - STUDENT DEFAULT**

- The applicant will be deemed to have defaulted where an applicant cancels their course, does not start on the agreed course date, and/or fails to notify of any circumstances that may affect the enrolment Where the applicant defaults, Greenwich English College will refund fees paid in accordance with the Cancellation and Refund Policy within 28 days of the effective notice date

  If you cancel your enrolment on or after your course commencement date, fail to notify of any circumstances.

## **CANCELLATION AND REFUND POLICY - VISA REJECTION**

- If your application for a visa to study in Australia is rejected before the commencement date of the course, and Greenwich English College is notified in writing accompanied by supporting documentation at least 48 hours prior to the commencement date, Greenwich English College will refund in full all tuition fees paid
- If your application for a visa to study in Australia is delayed, and Greenwich English College is notified in writing accompanied by supporting documentation at least 48 hours prior to the commencement date, Greenwich English College will (at its discretion) allow you to defer your course

  If you fail to notify Greenwich English College of any visa rejection and/or visa application circumstances that may affect your enrolment, Greenwich English College will refund in full, the unexpended pre-paid tuition fees which you have paid (that is the portion of fution fees for which you have paid but for which tuition has not yet been received presuming you commenced your course on the agreed date) 3
- If you commence a course at Greenwich English College and subsequently your visa application is rejected, Greenwich English College will refund in full, the unexpended pre-paid tuition fees which you have paid (that is the portion of tuition fees for which you have paid but for which tuition has not yet been received)
- In all cases under the Cancellation and Refund Policy the enrolment fee, instalment fee, credit card transaction fee, and accommodation placement fee are non-refundable

## **CANCELLATION AND REFUND POLICY - COLLEGE DEFAULT**

- Greenwich English College reserves the right to cancel a course and/or enrolment prior to the commencement date of a course (College default), in accordance with the Terms and Conditions of Enrolment
- Greenwich English College will be deemed to have defaulted where a course does not start on the agreed date, or if a course is not delivered in full
